14. Any Other Business

a) Gordon Brown: Exhibition principles

The exhibition has a lot of work and cost associated with it. Joe, Christine, Louise and Gordon are on a sub-committee looking into it and have had one meeting. Should the Exhibition be members only or not, judged or not judged? Joe has run a survey.

Anne Ruffell suggested we keep the format the same with a new team running it. Tony Smith noted that the cost is approximately balanced by the income. What is the objective of the exhibition? Accrediting BPE was suggested.

Ron Foulkes proposed the following motion : “The committee preserve the exhibition generally as it is.” This was voted on and carried, with 30 in favour and 7 against; the motion was carried.

The committee and the Exhibition sub-committee will now take that decision forward for the planning and preparation for next year’s exhibition.

Adrian Brophy pointed out that the whole debate on exhibition format (including from a beginners’ perspective) didn’t seem to have been explained to the membership. Failure to do so would make the committee seem rather foolish for having a pointless and confusing debate.

Roger Buchanan pointed out that the City Council wants the best exhibition possible to attract visitors to their space (which is under threat).

AOB item b) Bernice Hill : Keeping the beginners group for beginners – see note from Phil George :

Thank you for your email about the Beginners Competitions!

I am fully aware there is now a problem with this and we are looking at ways to make the Beginners section very much a Beginners section.

Unfortunately, the competitions have evolved rather unexpectedly due to a number of major changes over the last ten years, particularly the demise of the slides league, and the introduction of an Intermediate league for all classes in 2006.

Before 2006 we had a Beginners and Advanced Class for all categories, and we introduced an Intermediate class so Beginners, who maybe won the league or a major trophy, wouldn’t be forced straight into the Advanced League. At more or less the same time, the Slides leagues came to an end, and members who were Advanced in the Slides found that they were no longer able to compete in the digital world, and so asked to be demoted to Intermediate.

We have also had a situation whereby new photographers can start off and, because of access to many images and tutorials on the Internet, can actually become Advanced in a very short space of time, indeed, there are some Advanced members who have only been doing photography for just a few years, and could easily class themselves as Beginners not very long ago. Before the digital age, it would often take an amateur photographer years and years to learn how to print to a high standard and compete with the best.

So you can see our dilemma?

I am looking at ways of assessing new members when they join the Society to try and determine which class they should compete in, but it is very difficult when a new member joins and says he or she is a complete Beginner, and in no time at all, produces work which is "up there with the best"!

I am even looking to "shake up" the classes and promote a lot of members from the Beginners to the Intermediate or even Advanced where we see fit.
