**A/V Report** . George Walsh prepared a report which was read out: *So many Clubs now are producing there own A.V's and producing shows from within their own Club, thereby keeping cost down, that we have had little call for going out. We do have one that we shall be showing to in early June.*

*Within our Society two workshops have been held the first one in late November and the second one in February this one with Michael White who won the evening.*

*Regarding Club competitions the first one that we took part in was held at North Hants PS on 28th.January; competing were North Hants. Viewfinders and Winchester. We won the competition.*

*Friday evening 15th.April Winchester entered The Oak Leaf competition held by North Hants with six Clubs taking part North Hants, Alton, Overton, Viewfinders, Steyning and Winchester, Winning Club was Overton with Winchester taking second and Steyning third.*

Special Notice. *Very much in the minds of our group is the question of using music. Our Society holds a licence as we are a member of the I.A.C. (The Institute of Amateur Cinematographers). which means that The Society is covered only for productions made by them, and not by individual members. When we go out to a show or competition your work is "made" by the A.V. Group. . The copyright law is now seventy years after (the holders) death. But there is no problem using non-copyright music; such as it is.*
